## The Honorable Benigno R. Fitial and The Honorable Members of the Legislature

In accordance with 4 CMC Division 7, Section 7112, I am pleased to present the 2009 Annual Report of the Insurance Commissioner.

This report, which we hope you find useful, includes a listing of admitted insurers and a summary of insurance business transacted in CNMI from all admitted alien, domestic and foreign carriers during the 2009 calendar year.

During the reported year, the Office of the Insurance Commissioner licensed and regulated Four (4) alien carriers, sixteen (16) domestic carriers and forty-two (42) foreign carriers. No new COAs were issued for alien insurer but authority was granted for withdrawal of Mitsui Sumitomo Insurance. Four (4) new COA were issued to the following admitted foreign companies, bond Safeguard Insurance Company, Lexon Insurance Company, Colonial Surety Company and Tokio Marine Pacific Insurance Limited but authority was granted for withdrawal of United States Fidelity & Guaranty Company of Maryland and Seaboard Surety Company. No new COA was issued for domestic insurer.

2009 marked the fifth year in which surety companies issuing labor bonds are required to retain a certain percentage of premiums collected from the sale of labor bonds into an established escrow account. The retention rate in 2009 was 25 percent (25%). A total of \$207,317.00 was retained during the reported year.

Direct premiums written for Property and Casualty experienced a 16.6% decrease from \$23.5 million to \$19.6 million. Direct losses incurred decreased by 19.3% from \$10.1 million in 2007 to \$8.1 million in 2009.

#### RECOMMENDED LEGISLATION

The following are recommendations previously submitted in past reports of the Insurance Commissioner. To date, however, no action has been taken on these recommendations. It is the intent of the Insurance Commissioner to renew legislative interest and initiative in the re-submission.

#### **Capitalization Increase**

Pursuant to §7306(h) of the Commonwealth Insurance Act, a domestic insurer need only be capitalized at a minimum of \$25,000 to transact a class of insurance. It is recommended that this minimum be increased to \$100,000 per class to ensure that sufficient and adequate reserves are maintained by an insurer in the event substantial losses are experienced early in its operations.

#### Reinsurance

Current provisions of the Insurance Act relating to reinsurance are very limited. In fact, current provisions only provide for the admission or approval of reinsurers in the CNMI prior to engaging in business. It is suggested that, in addition to the current provisions, the Insurance Commissioner be granted further authority in requiring reinsurers to file reinsurance treaties and for the Insurance Commissioner to review and approve such filings.

#### **NAIC Membership Dues**

Since the Department of Commerce became a member of the National Association of Insurance Commissioners (NAIC) we have received valuable opportunity as state regulators. However, maintenance of the Department's membership with the NAIC is critical especially at this juncture when the Health Care Reform is nearing implementation. The NAIC has been instrumental in assisting the Insurance Section navigate through the very complex Patient Protection and Affordable Care Act (PPACA) and The Health Care and Education Reconciliation Act.

The annual membership dues has historically been paid for by grant funds provided by the NAIC to all its members. However, in 2009, the NAIC limited the use of grant funds strictly for training and attendance of national meetings only; hence the need for Commerce to source much needed funds to maintain its membership with the NAIC.

The Legislature has introduced H.B. 17-48, "To amend 4 CMC § 5611(d) to establish a revolving fund to pay for the National Association of Insurance Commissioners annual membership dues; and for other purposes.

As the regulator of the insurance industry in the Commonwealth, the Department is fully supportive of the enactment of this bill. Enactment of this bill would guarantee our annual membership with the NAIC.

As a matter of fact, we are still very dependent on the NAIC to provide the Insurance Section with the necessary guidance as we continue to navigate our way through these complex laws. The NAIC has been very pro-active in providing white papers and access to the ongoing debate and administrative review processes. We cannot emphasize enough the value of being a member of the NAIC. The NAIC gives us access to a wealth of resources. It provides such services as administrative form filings, legal reviews, claims and enforcement and compliance matters. Furthermore, the Insurance Section lacks the necessary resources necessary to fully monitor and regulate the insurance industry.
