























How the CPI can help us measure Price Changes.

The main purpose of a consumer price index (CPI) is to measure changes in prices of goods and service that a reference population (consumers) acquire, use, or pay for consumption.

The CPI calculations are based on a “BASE” year. In the case of the CNMI, the “BASE” year of our CPI is the third quarter of 1977.3) and our CPI shows the price increases compared to that year. Therefore a CPI of 271.2 for the fourth quarter of 2001, means that there was an average of 171.2% price increase for all items since the third quarter of 1977 till the fourth quarter of 2001 (2001.4); A span of about 25 years. While this number is intriguing, it is of course not realistic to compare prices to 25 years ago. A more realistic approach of course, would be to compare the 2001.4 prices to its previous quarter prices (2001.3) or its previous year quarter (2000.4). Table B shows that the overall prices in 2001.4 decreased by 0.11% compared to the last quarter (2001.3), and by .70% compared to a year ago. The only increase for the last quarter compared to the previous quarter was in Food, and Apparel & Upkeep.
